Growth for the E/D/E Group: With effect from 1 July 2023, United Hardware the most successful Buying Group in Ireland for Independent Builders, Plumbers, Hardware and Timber Merchants - will be working with E/D/E subsidiary EDE International AG.

The connection to the electronic warehouse eLC is one of the first steps in the cooperation, the expansion of which is already being planned. Among other things, cooperation in the area of the FORTIS private label, a partnership with the European Competence Group EHN and the financial services of ETRIS BANK are already being considered.

With its existing specialised dealers and suppliers, it offers the optimal conditions and thus the right foundation for creating effective synergies!"
